MINUTES OF THE MEETING OF THE QUALITY ASSURANCE COMMITTEE FOR STERILIZATION IN KARAIKAL DISTRICT HELD ON 18.10.2021 AT 11.00 AM IN THE CHAMBER OF THE DISTRICT COLLECTOR, KARAIKAL

At the outset, Dr.R.Sivarajakumar, Deputy Director (Immunization), Karaikal welcomed all the members of District Quality Assurance Committee. The Committee members discussed about the failure case of Sterilization of Tmt.A.Kavitha W/o. Anandhraj residing at No. 05, School Street, Kottagam, Nedungadu, Karaikal.

The Deputy Director (Imm.) explained the details of the surgery, failure of sterilization and the death of the third baby in the womb for the above said patient.

The District Collector, asked regarding the percentage of failure of sterilization and also regarding baby's congenital anomalies to the doctors from Govt. General Hospital, Karaikal. The doctors said that the chances of sterilization failure is 2% and it is accepted in medical literature.

The District Collector insisted to read the letter written by the patient and the Deputy Collector (Disaster Management) read the complete letter.

After going through the sterilization guidelines the District Collector directed to organize camps regarding the assessment and checking of Tubectomy and Vasectomy and the District Collector insisted that the assessment and checking of sterilization is the responsibility of District Quality Assurance Committee.

The District Collector enquired regarding the doctors who were involved in sterilization surgery and doctor involved in the third delivery of Mrs.A.Kavitha and collector was given the details by the doctors from GGH, Karaikal.

The District Collector went through the patient's case sheets and inquired whether this type of Intra Uterine Death occurred followed by sterilization failure in the last 5 years and the collector was told that no such Intra Uterine Death occurred in the last 5 years.

When the members of DQAC discussed regarding RKS registration they were asked by the District Collector to prepare the list of equipments given by all the Head of the Departments and to give an advertisement regarding this to public and were also insisted to put up the file.

The District Collector directed to give the claim amount of Rs.30,000/- (Rupees Thirty Thousand Only). The DQAC accepted the claim of the client and insisted to follow the further proceedings.

After a vote of thanks the meeting is concluded.
