ORDER

Whereas, the Health and Family Welfare Department shall be liable to double the quantum of compensation fixed for the Sterilization Failure Cases under the **Family Planning Indemnity Scheme** (FPIS) with effect from 01.01.2017, in pursuance of the communication of Department of Health and Family Welfare and Ministry of Health and Family Welfare, Government of India vide **D.O letter No.N.11017/C/1/2012-FP(Pt)**, dated **04.10.2016** and as per the Order of Supreme Court dt.14.09.2016 while disposing off the Writ Petition (Civil) No.95/2012 (Devika Bisvas v/s Union of India & Others).

2. Whereas, as per the directives of the Supreme Court of India, the Department of Health and Family Welfare, Puducherry has sent proposal for enhancement of quantum of compensation fixed for the Sterilization Failure Cases under the Family Planning Indemnity Scheme with effect from 01.01.2017 vide I. D. Note cited (1) above.

3. Whereas, one of the directives enlisted was doubling the quantum of compensation fixed for the Sterilization Failure Cases under the Family Planning Indemnity Scheme (FPIS) with the balance being paid from the State budget.

4. Therefore, the Lieutenant Governor is pleased to double the following quantum of compensation fixed for the Sterilization Failure Cases under the Family Planning Indemnity Scheme (FPIS) with effect from 01.01.2017, in order to facilitate the State and District Health Authorities in strengthening the process of compensation against adverse events following sterilization procedures as well as providing prompt indemnity cover to the clients / doctors / health facilities.

Whereas, the Office of the Deputy Director (Family Welfare & Maternity Child Health), Health & Family Welfare Department shall pay the revised pattern of compensation to the eligible beneficiaries / client in respect of Sterilization failure cases under Family Planning Indemnity Scheme (FPIS) with effect from 01.01.2017 as approved by the District Level Quality Assurance Committee(s) and State Level Quality Assurance Committee constituted vide G.O. Ms.No.09 Dated 31.01.2008 of the Chief Secretariat(Health), Puducherry as per the Manual for Family Planning Indemnity Scheme issued by the Government of India.

6. Whereas the settlement of compensation shall be met out from the Central and State funds as per guidelines of the Government of India issued from time to time. Every year, an amount of Rs.5,00,000/- (Rupees five lakh only) shall be borne as share of Central funds received from National Health Mission, Ministry of Health & Family Welfare Services, Government of India under Centrally Sponsored Scheme "National Health Mission" towards the Family Planning Indemnity Scheme through the Pondicherry State Health Society and additional expenditure for the claims under FPIS shall be met out from the State budget and the expenditure is debitabale under the following head of account :
