The Member Secretary, SQAC explained the nature of failure and procedure done for all the sterilization failure cases in Puducherry region hospital wise.

As per Chairperson's instruction in the previous meeting, the Member Secretary reviewed and read the Sterilization Failure cases for the last 10 years from 2011-2020. During that period, there were 28,550 tubal sterilization procedures performed parallelly during same period (2011-2020), in that 119 failures claims registered. As per this performance, the Average Failure Rate is around 0.416 which is at an acceptable level. These date pertain to RGGWCH only. Other hospitals have not submitted data.
