The Evaluation Report submitted by the Technical Committee as furnished below:

- i. Out of 16 items, 4 items only has been supplied as per the approved brand/manufacturer and remaining 12 items has been supplied with different / unknown brand of products.
- ii. Many of mannequin items have not been supplied with complete components.
- iii. The demonstration was not done satisfactorily.
- iv. The products supplied by M/s. Sairam Agency, Puducherry were not satisfactory.
